Phase II Update: Grantors requesting rebrand of #HealthierMO logo into PO logo for legislative items, conference call to follow with grantors. 2. Statewide Advocacy Training: Scheduled for April 29-30 and will be open to local partners but may expand. Will include PH advocacy education and medical marijuana along with other items. Agenda to be out within a week. There will be a special session at the capitol to allow time to talk with legislators. Governor will speak on 1st day. Scott will speak on day 1. 3. MoALPHA Legislative Tracking: group would like bill tracking regularly posted in Teamwork. Scott reported LPHA budget was not touched. PDMP is on the Senate Floor now after being reconsidered in Senate Committee. Watch SB 391, which will not allow Local Boards of Health & County Commissions to deal with Agriculture issues. DNR and Dept. of Agriculture to be regulators. Another bill of interest includes PH agencies ability to impound animals, he will continue to work with legislative group on this and report back. 4. Chair/Co-Chair Discussion: Set up Co-Chair/Vice-Chair system. Scott volunteered to Vice-Chair the Advocacy Workgroup. 5.
