## Announcement of Award Winners

### Missouri Public Health Association Announces 2020 Award Winners

The W. Scott Johnson Award is the most prestigious award presented by MPHA to an individual for distinguished service in the field of public health in Missouri. The award is given in commemoration of the skills, integrity, devotion to duty and constructive leadership which characterized the life of W. Scott Johnson. The 2020 winner of this award is **Gary**



**French.** Gary has worked for the Henry County Health Center for 13 years, he has filled many roles including Emergency Preparedness Coordinator, Community Educator, Teen Outreach Program Coordinator, MCH as well as HCHC Epidemiologist. When COVID hit, he took the lead for contact tracing while continuing with his contracts and community education. Gary's nomination for this award was endorsed by many community partners in the Henry County area.



The Group Merit Award is **Dr. Albert Hsu** and the **Boone County Medical Society**. This award gives recognition to an agency or group making a significant contribution to public health in Missouri within the past five years. The activity should have been beyond the usual public health activities engaged in by the agency. Dr. Hsu and the Boone County Medical Society were nominated for their significant and prolonged efforts in advancing the public's health in Missouri and their ongoing efforts at informing the Boone County constituents about the continuing COVID-19 pandemic affecting the state and the community.



The recipient of the Robert L. Northcutt Award is **Andrew Shaughnessy** of St. Louis. This award is presented to an individual or group who significantly advanced legislation to improve the public health of the citizens of Missouri.

Mr. Shaughnessy has worked tirelessly advocating policies and advancing programs that have positively impacted the health and well-being of Missouri's most vulnerable. Most recently his work to advance

the successful Medicaid expansion ballot initiative propelled him to being an advocate worth nominating for this award. His work in building the most diverse coalition seen in support of a ballot initiative and for partnering with the business community, faith, philanthropy, hospitals and multiple associations.

Effective public health strategies will lower costs for our healthcare system, but we must invest in public health in order to earn financial savings and healthier communities. Public health creates an environment where the economy grows, communities thrive, and all of us have the fair opportunity to reach our full potential. Public health is a shared responsibility between federal, state, and local governments. COVID-19 demonstrates that public health must have the resources and capacity to build community resilience and preparedness, issue and enforce public health orders, share information with key partners and the public, and lead the health and medical response to public health emergencies.


% OF COMMISSION HELD CARES FUNDING SHARED WITH LPHAS

## Tobacco Free Missouri

The statewide coalition dedicated to tobacco prevention, Tobacco Free Missouri (TFM) started 2021 defending ground gained at the local level for 100% smokefree indoor air laws, age of sales restrictions and other measures which face encroaching pressure from the legislature aiming at passing preemption to prevent local progress on any public health issue. This is not a new issue for TFM as the tobacco industry initiated preemption as a tactic to focus their power where they had the most allies, in state Capitol buildings, instead of on the ground in local communities.

Advancing local policy change remains a top priority for TFM Board and its members. There is still so much work to do as the case was clearly outlined in the recent American Lung Association State of Tobacco Control report where Missouri's staggering failure across all categories lands us squarely at the bottom of the list. Categories considered in the report include the same issues dedicated in the strategic plan for the coalition - increasing tobacco cessation and prevention funding, smokefree air, tobacco taxes,

access to cessation services, and progress on regulating flavored tobacco products. From the report's findings:

*The American Lung Association calls for the following actions to be taken by Missouri's elected officials to reduce tobacco use and exposure to secondhand smoke:*

1. *Increase state funding for tobacco prevention and cessation;*
2. *Pass comprehensive smokefree laws and policies at the local and state level; and*
3. *Increase tobacco taxes on all tobacco products.*


